

**GRAND SLAM TOUCHDOWN
“WIN THE WORLD” ENTRY FORM
WITH TERMS & CONDITIONS
SPONSORED BY CIRCLE 3 FARM, LLC**

SUBMISSIONS AND ELGIBILITY:

1. In order for entrant to win, eligible shows are only the AQHA Youth, Select, Amateur, and Open shows starting with 2010 shows only and the entrant must win first place as a world champion. In case of multiple world champions during the AQHA World Shows, the payout will be split equally between the first place winners. The final “Win the World” payout will occur after the last AQHA World Show for that particular year. In the event there are no first place winners, the “Win the World” payout will be carried over to the next year AQHA World Shows.
2. Entrants acknowledge and agree in order to qualify to receive the maximum “Win the World” payout of \$50,000, Circle 3 Farm, LLC (“Circle 3”) requires a minimum of 60 entrants who have paid the full stud fee and have properly qualified their entry with Circle 3. Entrants further acknowledge and agree that the minimum “Win the World” payout is \$25,000.
3. Entrants must print out, sign and mail in this entry form. Entrants can locate and print out this entry form on the Circle 3 internet website (www.grandslamtouchdown.com). Circle 3 will not be responsible for and will not consider incomplete or incorrect entries filled out and mailed. Circle 3 is not responsible for entries that are mailed but not received by Circle 3 at it’s listed address. Proof of mailing is not proof or receipt. Circle 3 does not accept any responsibility for late entries.
4. By submitting your entry to Circle 3, entrants represent and warrant the full stud fee payment has been made, and the entrant has full and unrestricted ownership rights in the foal, free and clear of any claims, liens or encumbrances. In the event entrant sells or transfers ownership of the foal, it is the new owner’s (entrant’s) responsibility to submit a new entry form indicating the transfer of ownership to be eligible for the “Win the World” payout. In addition, the new owner (entrant) will be required to sign a new acknowledgement to the Circle 3 “Win the World” Entry Form.
5. Re-breeds are allowed under the following conditions only: If a mare does not settle (become pregnant) and/or the foal is deemed unregistrable due to being classified as H/H, a rebreed is allowed to participate for the “Win the World” payout. The entrant will be provided new semen by Circle 3 at no charge with entrant paying the applicable shipping fees.
6. Entrants acknowledge and agree that Circle 3 shall have no obligation to post, display, or otherwise make publicly available any of the entry information submitted. By submitting an entry to Circle 3, entrants waive any privacy expectations they may have with respect to the entry information.
7. All entrants and winners must be at least 18 years of age, unless otherwise stated or posted.
8. No responsibility is accepted by Circle 3 for ineligible entries or entries made fraudulently.
9. Entries must be submitted as described to be eligible for entry. You may enter as often as you wish provided the full stud fee required is paid for each applicable foal as provided by Circle 3.
10. Employees of Circle 3 and their immediate families are not eligible to enter or win.
11. All qualifying entries will be posted on the Circle 3 internet website, www.grandslamtouchdown.com.
12. The “Win the World” contest award is void where prohibited by law.

WINNER NOTIFICATION:

13. All winners will be notified by the means provided within this entry form within five (5) business days.
14. The “Win the World” first place winner may be required to sign and return an affidavit of eligibility and a liability/publicity release (except where prohibited by law) and provide any additional information (such as social security number) that may be required for Circle 3 to comply with applicable law. Failure or delay in giving such requested information or approvals may result in disqualification. Entrant must sign a copy of these Terms and Conditions to be eligible to participate and/or receive the “Win the World” award. Entrant agrees to waive any penalties or violations of the 2004 Social Security Number Privacy Act. Circle 3 may use, reproduce, edit, display, transmit, prepare works of, modify, publish and otherwise make use of photos, drawings, text, and other content or information (collectively and severally, “Materials”) in any and all media, whether now known or hereinafter created and for any purpose without compensation to entrants of any kind.

RELEASE AND HOLD HARMLESS:

16. Entrants agree to hold Circle 3 and it’s members, employees, agents, successors, and assigns harmless from and against - and hereby waive and right to pursue - any claims of any nature arising in connection with Circle 3’s use of entry information submitted to Circle 3 and used in any manner in Circle 3’s sole and absolute discretion.

17. By entering and/or accepting the “Win the World” payout, entrants release and agree to hold harmless Circle 3 and its individual members, employees, representatives and agents from any and all liability for any loss or damage of any kind, including death, arising in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the payout or eligibility to participate and/or receive this “Win the World” payout.
